ENVIRONMENTAL SPILL RESPONSE PROGRAM

The policy you have purchased includes access to our Environmental Spill Response Program at no additional cost. This Program is designed to quickly dispatch clean-up contractors, expedite regulatory reporting, and mitigate potential liability and costs related to spills. We have partnered with a spill management firm that has over 20 years of experience with assessing and coordinating a spill response that assists our insureds in managing their spill emergencies that require environmental clean-up.

Through the Environmental Spill Response Program team, we provide expertise and assistance with spill incident reporting, response coordination, and documentation. A toll-free telephone hotline and internet reporting site is staffed around-the-clock to answer questions and to activate emergency spill plans. The Program is a 24/7/365 support system for you, that identifies and dispatches pre-qualified clean-up and response contractors, expedites regulatory reporting, and reduces costs associated with environmental releases.

You must enroll in the Environmental Spill Response Program online and create a custom spill contingency plan at our secure website: <https://century.spillcenter.net/reportspill.php>. After enrolling, you will be able to report a spill or incident, either online or by telephone, 24 hours a day, 7 days a week. The response center is staffed by legal, technical, engineering and environmental specialists that will advise you on the management of your environmental spill. The Environmental Spill Response Program team operates a national database of clean-up and response contractors, and service providers who are experienced and equipped to mitigate spill conditions. In the event of a spill, you will be provided with a list of eligible responders within the vicinity of the spill and you will select which responder to use.

The Environmental Spill Response Program team also coordinates all compulsory regulatory reports, using its database of nearly 30,000 federal, state and local jurisdictions that require incident reports from spill generators. They closely monitor changes in regulations and contact information at each level of government so that you may avoid fees and penalties for missing reporting deadlines.

Information about every incident is collected online and provided to the appropriate authorities, with your approval. The documents generated from the spill response and clean-up activities are also sent to you in the form of an electronic data package. Spill response and clean-up activities are then monitored in real time by the Environmental Spill Response Program team.

Once enrolled, you can incorporate the Environmental Spill Response Program directly into your risk management and loss prevention strategies as an integral part of your environmental management plan. The Environmental Spill Response Program team is also able to assist you in developing spill prevention, control and countermeasure plans to meet your facility's requirements.
